This Agreement does not create a contract of bailment. Visitor hereby releases Club from any and all liability for loss, death, damage or injury (collectively "injury") to any person or property arising out of or in connection with the condition or use of the Boat or the condition or use of the Club or its services, whether such Injury is caused by or through the acts or omissions of the Club or by any other cause whatsoever, including but not limited to, fire, theft, weather condition, etc., except for Injuries due to Club's gross negligence or willful misconduct. Visitor shall indemnify and hold harmless the Club from any claims, suits, actions, damages, liability or expense (including attorney's fees) in connection with any Injury (unless due to the willful misconduct or gross negligence of Club) or arising from Visitor's breach of the Agreement. Club is not to be considered as an insurer of Visitor's property and Visitor shall secure, at a minimum, the insurance required by this Agreement. Under no circumstances shall the Club be liable for indirect, consequential, special or exemplary damages, either in contract or tort (including strict liability and negligence) with respect to Visitor's use of the Club. Visitor and Visitor's insurers agree to waive any right to petition for exoneration from or limitation of liability under the laws of United States in the event the Boat is involved in any casualty resulting in personal injury, death or property damage while docked at the Club or in connection with this Agreement.

Visitor acknowledges that they have read and fully understand this Agreement and the Visitor's Guide to Club Facilities.
